- 2. DROP-OFF BOX** at the front of the school (Lillooet Street) from 8:45 to 9:10 am on April 13, 15, 22, 29, OR from 3:00 to 3:30 on April 23rd and 28th. Please make cheques payable to "Sir Matthew Begbie PAC". Unfortunately, the PAC is unable to issue a tax receipt with this method.
